



2014

Launch of the Paris Bar Incubator[IBP] with two tools: a think tank[1st study with ScPo : Legal innovation in France] + an accelerator of innovative projects



Multiplication of legaltechs,

Created at first by non-lawyers (or former lawyers) and followed by practicing lawyers

2017


